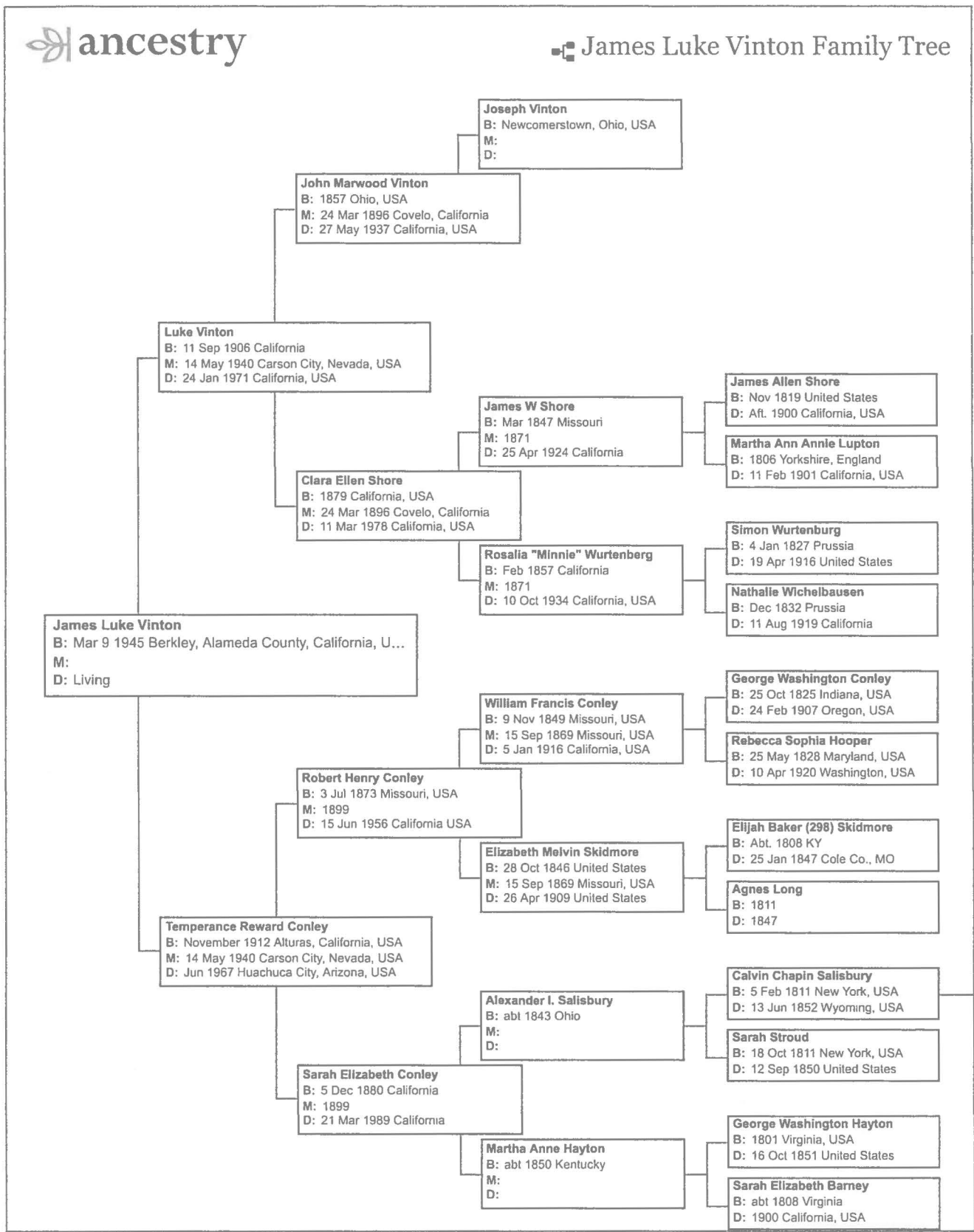
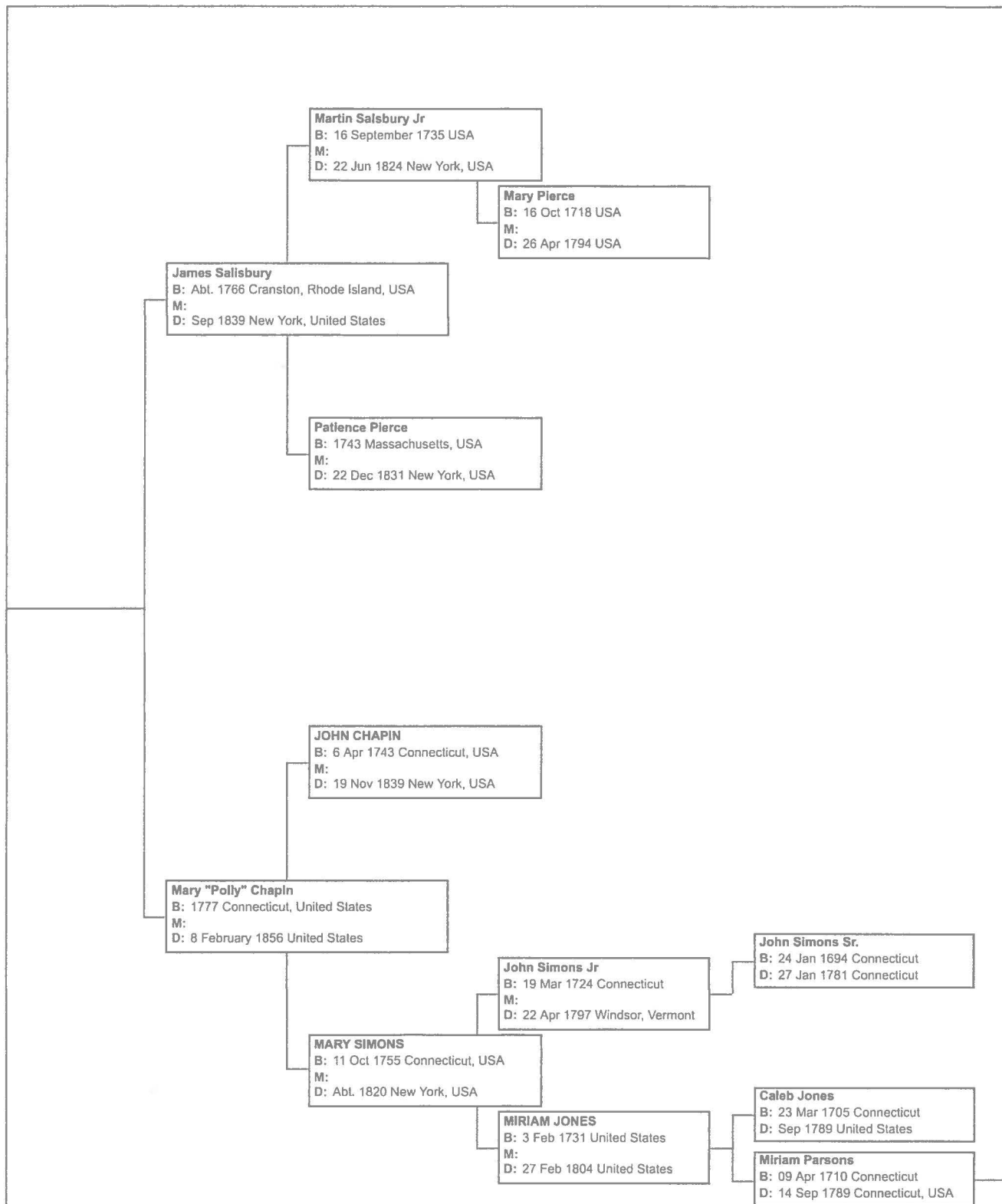




James Luke Vinton Family Tree
