



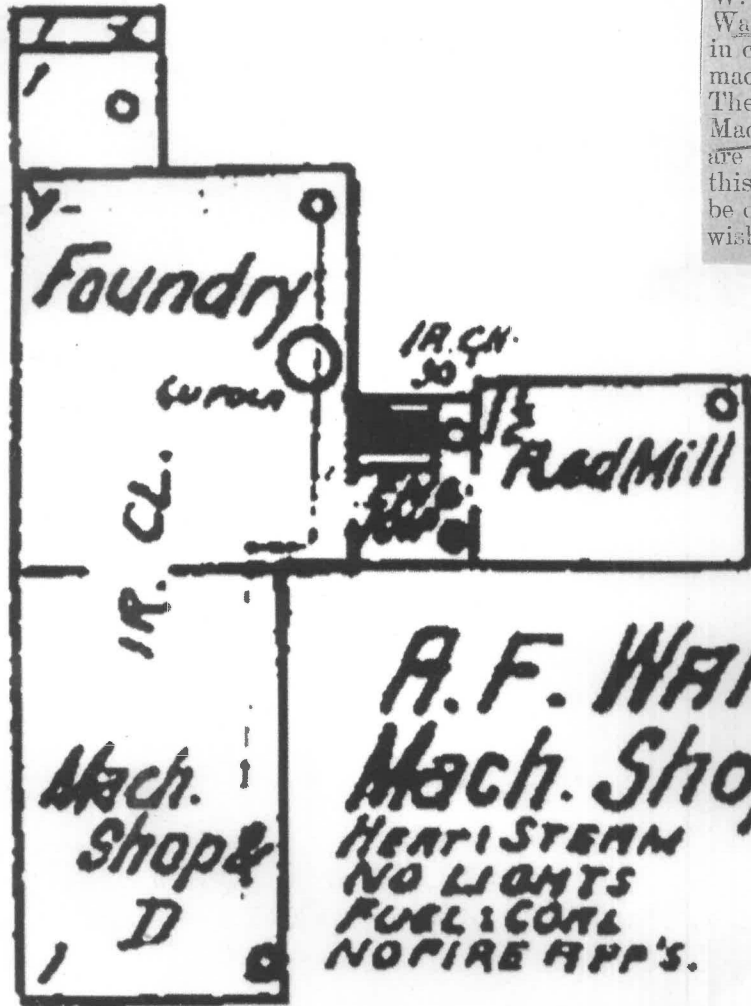

Older residents of this town and vicinity will regret to learn of the death of Mrs. Margaret Ward, former resident of Newcomerstown, who passed away at her home in Gnadenhutzen last Saturday morning.

Mrs. Ward was a remarkable woman. It will be remembered that when her husband conducted the machine shop on East Main st., she worked with him regularly, running drill presses, carrying heavy ladles of molten iron, in fact, doing work which her husband could not do on account of his age. Mr. Ward died after their removal to Gnadenhutzen. Her son Allen, who finished an enlistment in the navy last fall, remained with his mother during her last illness and death. Harry Skinner, a son by a former marriage, who is now in the naval service, was permitted to attend his mother's funeral. Funeral director D. L. Lydick of this city was called to take charge of the funeral which was held at Gnadenhutzen on Monday.

PLANING MILL BLD'G DESTROYED BY FIRE

Fire originating in the boiler room of The Newcomerstown Lumber Co. planing mill, East Main st. extension, last Thursday morning, caused the total destruction of the building and practically ruined all the machinery and finished lumber in the building.

Within a few minutes after the fire was discovered and the alarm turned in, the whole structure was a mass of flames. On account of the distance from fire plugs, the volunteer firemen had no chance to save the building, but fighting valiantly with a single hose they held the flames in check until another stream of water was secured when two sections of hose were joined together in order to reach another fire plug.

Shortly after the second stream of water was turned on, the firemen entered the burning building, fighting the fire at close range until the flames were completely under control.

The fire started at 10:30 a. m. and burned until about 1 p. m.

A large stock of lumber in the adjoining sheds was saved by the efficient work of the fire fighters.

The principal stockholders of the company are: Chas. Lieser, Eliada Lieser, Frank Mercer and Marion Mercer.

The entire loss is estimated at about \$7000. Insurance to the amount of \$2000 was carried through the Shannon agency in the Home Insurance Co. of New York. An adjustment of the claim was made Tuesday for \$1600.

OUR OLDEST CITIZEN ANSWERS LAST CALL

Mr. John Wilson, who came to Newcomerstown 80 years ago with his parents, James and Lydia Wilson, died at his home on Church st. at 3 a. m. Tuesday, Oct. 5, and was believed to be the oldest resident of our town. He was Newcomerstown's first mayor, and was a member of the first local band, of which Mr. O. A. Vogenitz was leader. Mr. Wilson was a Mason for over 50 years, and was the oldest living member of the local lodge. He was 1st Lieut. of the 80th O. V. I. and a member of the local Post. Also one of the oldest members of St. Paul's Lutheran church of this city. Mr. Wilson was for many years a contractor on the canal, and built many of the bridges and gates between Newcomerstown and Akron. He was associated with Mr. Case, also with Geo. Benton, in the planing mill business, and later conducted a grocery. He was reliable, honest and obliging in all his business transactions, and enjoyed the respect and confidence of all who knew him.

Mr. Wilson was born in Townsend, Delaware, Sept. 8, 1833, and was united in marriage to Margaret Blanpied, May 7, 1857. Mrs. Wilson preceded him last December. Two sons, Allen and Elisha, are dead, and the only daughter, Mrs. O. E. Wills of this city, survives. Other near relatives living are two brothers, Len Wilson of this city, and William of Cambridge, and a sister, Mrs. Perry Mackey; also 4 grand children and 3 great-grand children.

The funeral services will be conducted from the Lutheran church on Friday at 10 a. m., by Rev. O. C. Kramer, assisted by the Masonic fraternity, attended by the Eastern Stars, the G. A. R.s and Sons of Veterans.

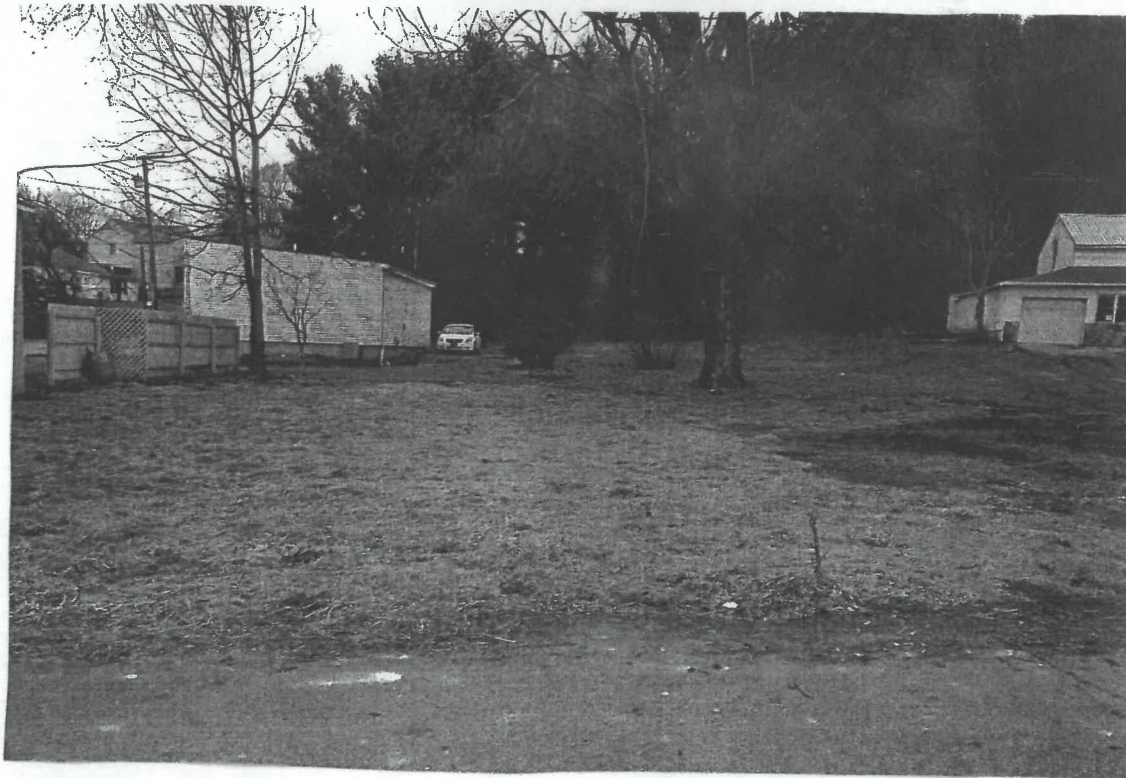

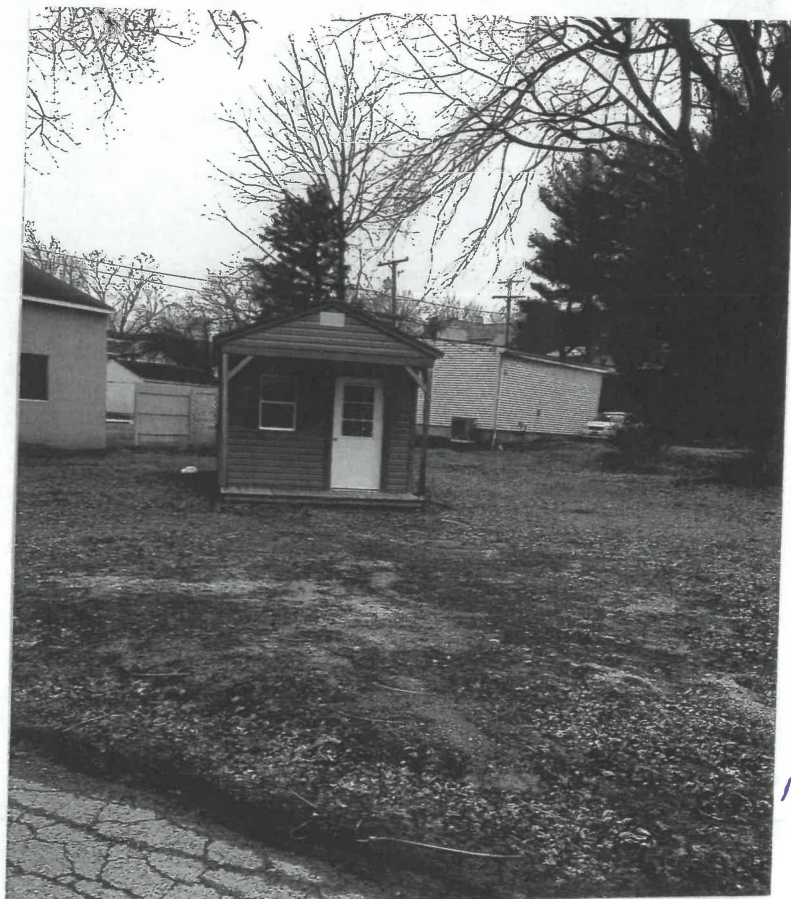

Byrd Ambulance Service Adds Another Unit Here

A new ambulance has been added to the Newcomerstown Company of Byrd Ambulance Service — a 1973 combination, Superior coach on Cadillac chassis.

Cost of the unit is \$17,675 plus sales tax and equipment. It will be fully equipped for any emergency or invalid trip, the same as the other units, including two-way radio. There will now be three ambulances housed at the Newcomerstown company with more units available from other branches.

There are also two airplanes on stand-by for non-stop ambulance flights to any burn-center or other hospital in the United States.

Jess Byrd, owner of Byrd Ambulance Service, said "Newcomerstown area is deserving of the best ambulance service possible, well equipped and with well trained personnel to take care of the sick or injured. Prices are less than or comparable to any other professional ambulance service in the surrounding areas and nation."

David B. Leading, manager of the Newcomerstown Company has invited citizens, business and professional people to stop in and visit the service garage at 230 E. Main street ext.

Leading said, "We are proud

of our cars, equipment and training and want the people of Newcomerstown and surrounding area to see what we have available in their time of need. We will strive to give prompt, efficient and courteous service without delay and will answer calls anywhere anytime.

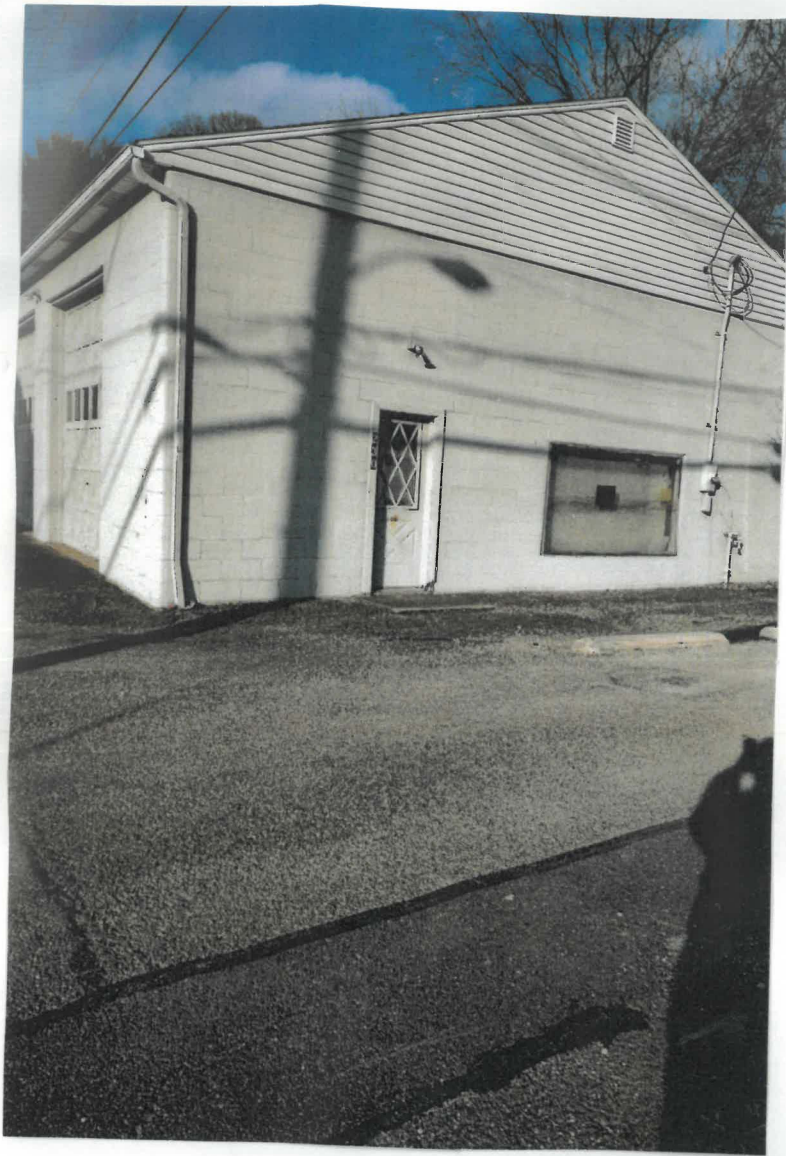

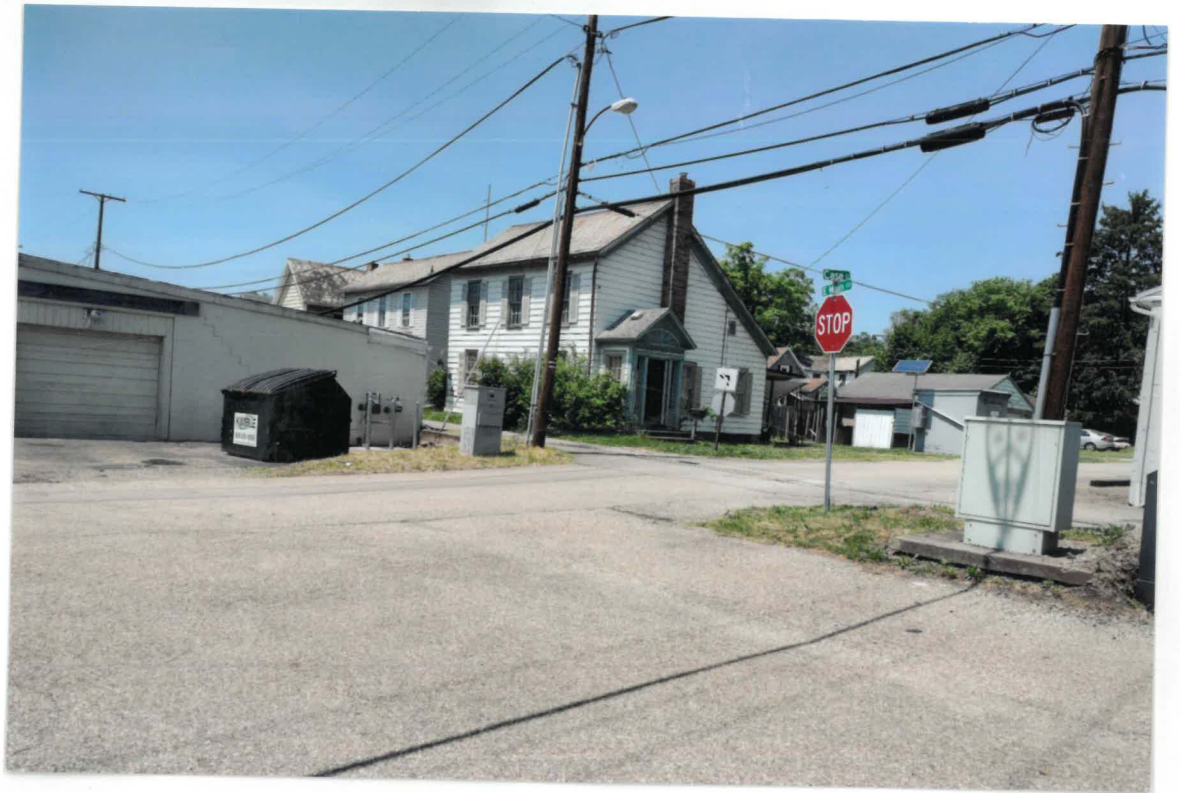
